PARISH GOVERNANCE

- A. Annual Meeting
 - 1. The Annual Meeting shall be held in January at a time and place designated by the Vestry. Public notice of the Annual Meeting shall be given to the congregation at least two weeks prior to the Meeting via eBlast, (or similar email communication,) notice in the bulletin and at all worship services prior to the Meeting.
 - 2. The purpose of the Annual Meeting shall be to elect members to the Vestry; receive reports from the Vestry, parish officers, and organizations; including any reports about the budget approved by the Vestry for the new year; and to transact such other business as may properly come before it.
 - 3. At the Annual Meeting, a report of the Parish finances shall be given. This report shall include, but not be limited to: 1) a report of the finances of the preceding year, 2) reports of all assets and liabilities and all income and expenditures of any subsidiary or related organization or entity, including (but not limited to) all trusts, endowments or other accounts, and 3) a budget for the year in which the Annual Meeting is held.
 - 4. The Annual Meeting shall be presided over by the Rector or Priest-in-Charge, or if the office be vacant, or if the Rector or Priest-in-Charge be absent, by the Senior Warden.
 - 5. Lay Members in good standing of the Parish who are physically present, who are at least 18 years of age, who are regular attendants at the services of the parish, and are consistent contributors to the support of the Parish, shall be entitled to vote at all Parish Meetings. A

quorum for the transaction of business in the Annual Meeting shall consist of 25% of the persons entitled to vote if they were present or 25 persons entitled to vote, whichever is less. The Vestry may by resolution permit one or more members to participate in a Parish Meeting by means of conference telephone or other electronic technology by means of which all persons participating in the meeting can hear each other in a manner that is substantially simultaneous and continuous. Participation in a meeting by conference telephone or other electronic technology shall constitute presence.

6. The Vestry shall consist of not fewer than three or more than nine Lay Members, at least 18 years of age in good standing, elected at the Annual Meeting.
7. The qualifications of persons to serve on the vestry shall be the same as the qualifications to vote at the Annual Meeting as set out above except that the person to be elected need not be present at the Meeting.
8. No cleric or member of a cleric's family shall be eligible for election as a member of the Vestry. No employee of the Parish or member of the employee's family shall be eligible for election to Vestry. No more than one member of a household may serve on Vestry at the same time.
9. The Vestry may by resolution designate a Nominating Committee, otherwise the Rector or Priest-in-Charge together with either Warden shall be the Nominating Committee. The Nominating Committee shall publish to the parish two weeks prior to the Annual Meeting a ballot with sufficient qualified nominees to fill the vacancies on the Vestry for the coming year.
10. Additional nominations may be made from the floor of the Annual Meeting. The nominator shall first obtain the consent of the nominee. Any question of the nominee's qualification to serve shall be resolved by the Rector or Priest-in-Charge prior to the election of Vestry members. In the absence of a Rector or Priest-in-Charge, the Senior Warden shall have the responsibility for determining the qualifications of any person nominated from the floor.
11. Each Annual Meeting shall elect persons to serve on the vestry replacing those members whose term in office has ended. If there are insufficient nominees to fill all vacancies, the Annual Meeting may reduce the number of persons to serve on the Vestry, subject to the limitations in #6 above. If the nominees are insufficient to fill slots for three members, the Rector or Priest-in-Charge, together with the remaining Vestry members may appoint a member in good standing to a one-year term.
12. The length of one term of office for members of the vestry shall be three years, with one third of the members, or as near as may be, elected each year at the Annual Meeting. A Vestry member shall not be eligible for re-election until one year after his or her third term has ended.

B. Special Parish Meetings

1. A Special Parish Meeting may be held at any time on the written order of the Ecclesiastical Authority or of the Rector or Priest-in-Charge, or by resolution of the Vestry, or on a petition to the Ecclesiastical Authority if such petition be signed by not less than 25% of the number entitled to vote at the last Annual Meeting.
2. All such orders, resolutions, or petitions shall specify the time and place of such meeting and the business to be considered.
3. At such meeting, no business shall be considered other than that specified in the call.
4. Notice of such meeting shall be given to all members of the congregation at least two calendar weeks prior to the meeting. This notice shall specify the time and place of the meeting (or provide the appropriate links to an electronic meeting), the business to be considered, and by whose order the meeting is called.

5. Such a meeting may be presided over by the Bishop. If the Bishop does not preside, the Rector or Priest-in-Charge shall preside. If there is no Rector or Priest-in-Charge, the Ecclesiastical Authority may request the Senior Warden to preside.

C. The Vestry

1. Duties of the Vestry

- a. In accordance with the Constitutions and Canons of The Episcopal Church and of this Diocese, the Vestry shall govern the parish and shall manage and be responsible for its property and material affairs; shall further the temporal and spiritual welfare of the Parish; provide a suitable place of worship and see that it is provided with all things necessary to the worship of Almighty God; shall select and call a Rector and provide for the renumeration of the Rector; and shall comply with all other requirements of the Canons of the church.
- b. As to civil matters, the Vestry shall be the corporate Board of Directors. The Rector or Priest-in-Charge shall be a member of and preside over the Vestry and is the President of the corporation. If there is no Rector or Priest-in-Charge then the Senior Warden shall be the President of the Corporation.
- c. In consultation with the Rector or Priest-in-Charge all staff positions are created and funded by the Vestry. Personnel filling those positions are hired by and serve at the discretion of the Rector or Priest-in-Charge and are accountable to the Rector or Priest-in-Charge. The Rector or Priest-in-Charge may work collaboratively with a nominating or personnel committee in the selection of personnel.
- d. A financial report shall be given at each regular meeting of the Vestry, which shall include current income and expenditures. Following approval, the report shall be made available to members of the congregation by request.
- e. The Manual of Business Methods, as issued from time to time by the Episcopal Church, shall be used as a guide for the conduct of business.

2. Officers of the Vestry and Parish

- a. The Lay Officers of the Church of the Redeemer shall consist of the Senior Warden, Junior Warden, Clerk and Treasurer who shall all be adult Lay Members in good standing of the parish and at least 18 years of age. No cleric or member of a cleric's family shall be eligible for election as an Officer of the parish. No employee of the Parish or member of the employee's family shall be eligible for election as an Officer. No household member of a Vestry member may serve as an Officer of the Parish.
- b. The Senior Warden shall be nominated by the Rector or Priest-in-Charge from among the members of the Vestry. The nomination is affirmed by majority vote of the members of the Vestry. If there is no Rector or Priest-in-Charge, the Vestry shall ask the Ecclesiastical Authority to make the nomination.
- c. It is the duty of the Senior Warden to work closely with the Rector or Priest-in-Charge, to advise the Rector or Priest-in-Charge on all matters pertaining to the parish upon which the Rector or Priest-in-Charge may wish to consult the Senior Warden, and to inform the Rector or Priest-in-Charge of all matters which the Senior Warden feels the Rector needs to know. If there is no Rector or Priest-in-Charge, it shall be the duty of the Senior Warden to assume all the temporal duties of the Rector or Priest-in-Charge including, but not limited to, presiding at Vestry meetings, signing documents, filing reports, and maintaining the Parish Register. In addition, it shall be the duty of the Senior Warden to provide for the continuation of Divine worship.
- d. The Junior Warden shall be elected annually from among their number by the Vestry. In the absence of the Senior Warden, the Junior Warden is to assume the duties of the

Senior Warden. It is the duty of the Junior Warden to oversee the care and maintenance of the building and grounds of the Church of the Redeemer.

- e. The Wardens shall see that the financial obligations of the Parish are met and that the building is kept in good repair and is adequately insured. Under the Rector or Priest-in-Charge, they shall see that all things needed for the orderly worship of God and for the proper administration of the sacraments are provided. In the absence of a Rector or Priest-in-Charge, they shall, with the advice of the Ecclesiastical Authority, procure suitable supply for the continuance of the services, to include but not limited to supply clergy or appropriately licensed/trained lay worship leaders.
- f. A Clerk shall be elected annually by the Vestry. The Clerk may, but does not have to be a member of the Vestry. When not a member of the Vestry, the Clerk has seat, but not voice and vote on matters coming before the Vestry. The Vestry may at its discretion allow the Clerk to have voice on any matter the Vestry deems appropriate. The Clerk shall be responsible for seeing that minutes are taken of all Annual and Special Parish Meetings and of all meetings of the Vestry and ensure that copies of said minutes and related reports are maintained in the electronic records of the parish as well as a hard copy kept in parish files as recommended by the *Manual of Business Methods*. The Clerk, on behalf of the Vestry, shall also be responsible for sending thank you notes or other acknowledgements as the need arises. The Clerk shall turn over to his or her successor all books and documents in his/her possession that belong to the Parish.
- g. A Treasurer shall be elected annually by the Vestry. The Treasurer may, but does not have to be a member of the Vestry. When not a member of the Vestry, the Treasurer has seat and voice. Under the authority of the Vestry, the Treasurer is responsible to collect, receive, disburse, and account for the funds of the Parish. Prior to the Annual Meeting, the Treasurer shall present to the Vestry a full and accurate statement of the financial condition of the Parish. At every meeting of the vestry, the Treasurer shall report the total assets and liabilities of the Parish and the income and expenses of the general operating funds. As directed, the Treasurer shall report the income and expenses of any other funds. The Treasurer shall be bonded at the expense of the Parish. The Treasurer shall turn over to his or her successor all books, documents, and funds in his or her possession that belong to the Parish.
- h. The Vestry may fill any mid-term vacancies in their number or among the officers of the Parish by majority vote.

3. Meetings of the Vestry

- a. Regular meetings of the Vestry shall be held at least quarterly and are anticipated to meet monthly September through June. All Vestry members are expected to be present at Vestry meetings. If any member of the Vestry is absent from three consecutive meetings without due cause, as determined by the Rector or Priest-in-Charge and the Wardens, that seat shall be declared vacant. The Vestry may permit one or more Vestry members to participate in a Vestry meeting by telephone or other electronic technology.
- b. The Vestry shall not transact any business without the presence of the Rector or Priest-in-Charge, or in the event that the office of Rector or Priest-in-Charge be vacant, without the presence of one of the Wardens. A quorum consisting of a majority of the elected members of the Vestry must be present for the Vestry to transact business. No action affecting the rights of the Rector or Priest-in-Charge shall be taken at any meeting at which the Rector or Priest-in-Charge has not been given the opportunity to attend.
- c. Special Meetings of the Vestry may be called at any time at the request of the Rector or Priest-in-Charge, or any two Vestry members. Notice of such meeting shall be given to

the Rector or Priest-in-Charge, the Wardens, and the members of the Vestry. This notice shall specify the time and place of the meeting and the business to be considered. No other business shall come before such special meeting except with the unanimous consent of the Rector or Priest-in-Charge and all members of the Vestry.

4. Indemnification

- a. No member of the vestry shall be personally liable for monetary damages for any action taken, or any failure to take any action, unless said person has breached or failed to perform the duties of the office prescribed by the By-Laws, and the breach or failure to perform constitutes self-dealing, willful misconduct or recklessness. The provisions of the section shall not apply to the responsibility or liability of said person pursuant to any criminal statute, or for the payment of taxes pursuant to local, commonwealth or federal law.
- b. The Church of the Redeemer shall indemnify any Vestry member who was or is a party to, or is threatened to be made a party to or who is called as a witness in connection with any threatened, pending, or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, including any action by or on behalf of the Parish by reason of the fact that he is or was a member of Vestry against expenses, including attorney's fees, judgments, fines and amounts paid in settlement actually and reasonably incurred in connection with such action, suit, or proceeding unless the act or failure to act giving rise to the claim for indemnification is determined by a court of competent jurisdiction to have constituted willful misconduct or recklessness. With respect to any such action, the Parish may participate, at its own expense, and the Parish shall be entitled to assume the defense thereof, with Counsel selected by the Parish to the reasonable satisfaction of the party being indemnified. After notice from the Parish to such person of its election to assume the defense thereof, the Parish shall not be liable to such person for any legal or other expenses subsequently incurred by such person in connection with the defense thereof. Such person shall have the right to employ separate Counsel in such action, but the fees and expenses of such Counsel incurred after a notice from the Parish of its assumption of the defense thereof, shall be at the expense of such person.

D. AMENDMENTS

The Vestry shall have the power to make, alter, amend and repeal the By-laws. Any amendment shall be proposed in writing to at least one regular meeting of the Vestry previous to final action and be adopted at the next regular meeting or any adjournment thereof, by a majority vote of the Vestry members present. After adoption, the amendment takes immediate effect.

Minutes of the 148th Annual Meeting of the Church of the Redeemer

January 26, 2025

The meeting was called to order by Rev. Cn. Melinda Artman on January 26, 2025 at 12:45 PM. The meeting began with Rev. Cn. Artman reviewing what was needed to have a quorum. By the Canons, we need 25 participants or 10% of eligible members. We have 40 eligible members thus would need 4 members for a quorum. We have more than enough participants for a quorum.

Annual Meeting Minutes 2024:

It was moved by Margaret Cole, seconded by Linda Murrelle, to approve the 147th Annual Meeting Minutes. The motion carried with no discussion.

Nominating Committee:

Betsy Schumacher and Jeff Watson are not eligible to run for Vestry for the upcoming term. They both have been extremely devoted to Vestry and we are thankful for their hard work and devotion.

Nominees: Doreen Marshall, Linda Murrelle, and Diane Siebecker. There were no nominations from participants at this meeting. It was moved by Alice Bennett, seconded by Bruce Carpenter, to close the nominations. Motion carries. It was moved by Bruce Carpenter, seconded by Margaret Cole, to direct the Clerk of Vestry to cast one ballot for the election of Vestry members. Motion carries. Diane Siebecker, Clerk of Vestry, cast one ballot for the above-named nominees.

Parish Register:

Reviewed and no questions.

Rector's Report:

Rev. Cn. Artman reports she works quarter time for our Parish, an other quarter time for St. John Lutheran Church. We pay for a quarter of her salary, a quarter from St. John, and half of which is paid by the Diocese. Thus, it is challenging to meet everyone's needs. Meeting the needs of our parishioners is of paramount importance. I plan to resume parishioner visits as requested.

Two of our youth were wondering how to get baptized. Classes were held and we had three youth receive Baptism during 2024.

August 17th, 2025 Bishop Kevin Nichols will be presiding over worship here at Redeemer. We are planning one Confirmation at that time.

I would like to recognize Linda Murrelle for her years of service preparing community suppers. She is hanging up her apron and Alice Bennett will be taking over. A plaque was presented to Linda. A newspaper picture and article will be in the local paper.

Senior Warden's Report: Reviewed and no questions.

Junior Warden's Report: Reviewed and no questions. Vestry would like to recognize Jeff Watson as our Chairman of Building & Grounds for life.

Youth Group Annual Report: Reviewed and no questions.

Sunday School Annual Report: Reviewed and no questions.

Also reviewed projects completed and those in progress. The 2025 Budget is projecting a deficit but not bad as we watch our spending. Bruce was thanked for his hours upon hours of hard work.

In keeping with Diocesan canons and by-laws, all parish officers (wardens, clerk, and treasurer) serve one-year terms and are appointed by the Vestry (as opposed to being elected by the congregation).

Wardens must also be elected to a three-year Vestry term. The clerk and treasurer MAY be elected to the Vestry or be appointed by the Vestry. If they are simply appointed, they do not serve as Vestry members.

Parish Officers: Margaret Cole, Senior Warden; Alice Bennett, Junior Warden; Diane Siebecker, Clerk; and Bruce Carpenter, Treasurer.

Nominees: The nominating committee made up of the Rector, the wardens and retiring members have asked Margaret Cole, Bruce Carpenter and Jeff Watson to run for Vestry. Although we have two vacancies, the Vestry could be returned to a nine member board. All the nominees have agreed to serve if elected. Nominations may be made from the floor of the Annual Meeting. Please make sure that you have a nominee's consent prior to nomination. In the event of a contested election, paper ballots will be issued. Since there are three vacancies for a three-year term, and if there are no nominees from the floor, it would be appropriate for a motion to be made asking the secretary to cast one ballot for the slate. Eligibility requirements for participating in the Annual Meeting as well as running for Vestry include being at least 18 years of age, regularly attending worship, being a regular contributor for the six months preceding the meeting to the support of the parish and being present at the meeting.

1 Roughly between Memorial Day and Labor Day our Sunday worship is combined with St. John Lutheran Church. This impacts how average Sunday attendance is calculated. The first number indicates the average based upon 52 Sundays, the second number is the average of 46 Sundays.

2 Of those who died, only two were carried in our register as baptized members.

3. In 2024, our parish had five deaths of which only one was carried as an official member of the Church

of the Redeemer. Those who died were: Helen Tracy, Shirley Spears, Audrey Garfield, Beverly A Hill, and John Anderson.

Rector's Report 2025

Rejoice in the Lord always; again I will say, Rejoice. ~Philippians 4:4

My Father is glorified by this, that you bear much fruit and become my disciples. ~ John 15:8

In most ways, 2025 was a very good year at the Church of the Redeemer. We welcomed into the household of God through the sacrament of baptism two babies, one child, two youth, and one adult. At the Bishop's visitation in August, we received four Christians from other denominations as Episcopalians. We welcomed into our parish family at least eleven others who have become regular worshippers, two at our Saturday afternoon service and nine at our Sunday worship. Our recent upgrade in our sound system along with a camera has increased the numbers of people who participate in our worship remotely. Thanks to our parishioners' support and the Conklin Trust we have been able to undertake needed investments in our physical plant. Our partnerships with area churches continue to expand and our relationship with St. John Lutheran Church remains strong. Reflecting on this fruitfulness, I rejoice.

Christian Formation. During the season of Lent (thanks to two of our youth group members insisting upon being baptized) I gave instruction in the faith to our four faithful youth group members. We enjoyed good food, explored the meaning of the Apostle's Creed and the Baptismal Covenant, and made crafts together. We had fun. Much credit for these young people's formation goes to our Sunday School team of Bonnie and Emily Garrity, Betsy Schumacher, and Kristin Stone. These faithful teachers of the faith share our foundational Bible Stories and provide our young people with a sense of our Christian heritage. They continue this good work during Vacation Bible School, which was hosted by St. John this year. We (St. John and Redeemer) teamed up with Valley United Presbyterian Church and Sayre Christian Church. Our program was "Waves of Wonder" and our children seemed to enjoy the program.

For adults, I offered an Inquirer's Class to prepare our four members for Reception when Bishop Kevin Nichols came for his once every three years visitation. During Lent, we had roughly 20 people between my two congregations participate in a six week Bible Study on the Parables, by Josh Scott. For the first time, I offered a morning session and an evening session. In late October, I offered a four week Bible Study in preparation for Advent using a book by Matthew Skinner, where 18 people participated.

Both book groups were well received.

Margaret Cole continues to do an amazing job as our singular Youth Group leader. Our youth adore her. From January to June, I was with Margaret at our weekly Youth Group gatherings. From September to December, I dialed back my participation to monthly, and Margaret has recruited other volunteers to assist her with the kids from both of my parishes. This has worked out very well so far.

Partnerships: I have a full time ministry thanks to the Diocese of Bethlehem, St. John and you. This partnership enables me to see best practices elsewhere and use good ideas that I find here. I hope that this also helps inform my preaching and I still hold your attention from week to week. As noted above our Vacation Bible School was jointly shared by four area churches. Since the number of young people participating in VBS is declining, there is some thought that 2026's VBS be either multigenerational OR geared towards adults.

Our most significant partnership is with St. John. With them we hold joint summer worship, they host us for Family Game Night and a monthly craft day. They participated with us in the Community Supper and the Parish Park Fair. They help with our rummage sale and we helped with theirs. They also provided some volunteers to assist with our Fall Fair and the Parish Park Fair. Together we engaged in a community garden ministry, helping to feed those who are food insecure. We participate in one another's Shrove Tuesday pancake supper, rotating from year to year as host. They also invited us to a potluck in October and in December. We are tentatively exploring together whether and how to worship together outside of the summer months.

Property: A building and property as old as ours require lots of tender loving care. Volunteers mow our lawn, trim our hedges and plants, weed, plant flowers, and shovel our sidewalks. They can always use more help. I am grateful for how they keep our property beautiful. This year our Vestry undertook replacing our 40+ year old parking lot. By necessity, we had to replace our alarm system as replacement parts were no longer available and reporting an incident like a fire became unreliable. At the Bishop's suggestion, we applied for and obtained a grant for 50% of the cost of installing a new sound and camera system. It was operational just before Christmas and initial reports are very positive.

Next year, the Vestry has budgeted for refinishing the Church's front doors, replacing the Parlor flooring, and upgrading all our light fixtures to LEDs. This change should positively affect our electricity bill. A suggestion has been made that it would be nice to have cushions on the pews. This could be an opportunity to form a needle crafting group to make cushions. This could be a ministry, fun and fellowship all rolled into one.

Church of the Redeemer also offers a home to Taking Off Pounds Sensibly, Strong Women, Strong Bones, and we are the host organization for The Boy Scouts.

We are not immune to change. Long-time Altar Guild head Phoebe Marshall and her daughter Sherry Gabauer decided to retire from this ministry. They have been dedicated members of the Altar Guild and have served as the "go to" people with questions about all things logistical when it comes to worship. I am very grateful to them for their often unseen work. All that's left to say is "well done faithful servants." I am glad to see that both continue their contributions to the Community Supper. Speaking of which, the Community Supper also saw a change in leadership. Linda Murrelle decided to hang up her apron and pass the wooden spoon on to Alice Bennett. To our regulars the hospitality

continues to be as warm and nurturing as the food. Another change this year was the cancelation of one of our rummage sales due to an insufficient number of people to staff the event. This limitation caused a rethinking of how to operate the Holiday Celebration (formerly Fall Fair), which was scaled back and much to our delight was more profitable than last year.

Vestry I am blessed to work with and for such capable and faithful people in leadership. All our Vestry members work very hard on the parish's behalf. Their many varied gifts are reflective of a cross section of our parish. Our officers devote even more time to the running of the parish and thanks to the work of all the parish runs smoothly. They take the stewardship of our resources very seriously. With the Conklin bequest, they have decided to share \$250 each quarter with a local charity. In this last year, Big Brothers, Big Sisters of the Northern Tier, Grace Connection (an organization similar to the Bridge, working in the Towanda area and housed in our sister congregation, Christ Church) and Kids at Risk, and the Bridge have received these small gifts.

We continue to be blessed by the music provided by Marcella Chaykowski. Geraldine Evans is the consistent presence in our office and is always a joy to encounter offering a pleasant word and positive outlook to all our visitors. Jerry also is the sole voucher writer for the parish, interviewing clients of The Bridge for such things as rent, furniture, and utility assistance. Finally, Maria Layton lovingly cleans our building as if it were her own. Her tender loving care of our building is greatly appreciated.

Diocese

My work for the Diocese includes supporting the other 27 parishes in the northern part of the Diocese of Bethlehem. This is done primarily through attending Convocation meetings: one meets monthly, another meets quarterly and the third (ours) meets very occasionally. I have also supported parishes in transition, that is parishes looking for a priest. This remains challenging as nationally there are more parishes looking for a priest than there are priests looking for a parish. I also served on two working groups that met to assist with the reunification of Bethlehem and Central Pennsylvania: Commission on Ministry and Constitution and Canons. I devoted significant time to working on the Constitution and Canons. My passion for both of us locally and regionally, is forming partnerships among and between congregations. The work the Northeast Pennsylvania Synod of the ELCA (of which St. John is a member) has a model of six geographically close parishes, working with three clergy and six lay worship leaders, focusing together one mission-related ministry. This model allows individual congregations who cannot afford a full-time member of the clergy to achieve full time clergy coverage and allows the clergy person to have a full-time job. So far, this looks like win-win. The Episcopal and Lutheran parishes in Bradford County might see themselves in such a partnership. I am supporting a similar effort in both the Scranton area and Wilkes-Barre area. In the Diocese of the Susquehanna, my responsibilities will be exclusively focused on the northeastern portion of our Diocese – no more priest searches outside of our geographic area.

Buildings and Grounds Report 2025

There were many small projects and repairs made to the Church and grounds during the past year. However, there were two capital projects that took place in 2025. The first capital project was the replacement of our parking lot, which had deteriorated substantially over the past few years. It was decided that we would not merely repair the existing surface as the base material of the area had subsided causing damage to the surface material. The parking lot was removed in its entirety then re-graded and packed. Four inches of asphalt was applied over the new base. The newly built parking lot will last us far into the future. The second capital project was the replacement of the sound system in the church with a state-of-the-art audio/visual system. The new system allows us to stream and record services as well as enhance the audio to improve clarity throughout the church proper. For those of you who have not yet experienced the audio clarity in the church the improvement is nothing short of amazing. The new visual portion of the system will allow those who view services at home to enjoy a clear, uninterrupted view. The new system also allows us to record while streaming special events such as weddings or concerts on a thumb drive. The high-resolution camera is capable of rotating 340 degrees for viewing from the back of the church up to the high alter, showing the entire event in real time.

A smaller, but no less important project took place in the fall of 2025 when we replaced the alarm system in the office area and the sacristy. Several outside doors were added to the system as well as new smoke alarms. This system will provide much improved coverage to our building for years to come.

We have a capital project scheduled to start in mid to late January of 2026. We will be replacing all of the fluorescent lights in the building with LED lighting. To minimize cost we will not replace the light fixtures, we will be converting the existing fixtures to LED compatible. LED lighting costs approximately 75 to 80% less to operate than our current fluorescent lighting. In addition, LED light bulbs have a life span that is between 4 and 5 times longer than our current lighting system. This project will take place in steps to minimize disruption in the lower parish hall and kitchen areas. There is a total of 75 light fixtures to be converted.

I would like to thank everyone who has helped keep our church beautiful by mowing and clearing snow. Your work never goes unappreciated or unnoticed by both church members and neighbors! A special thanks goes to Jim Bennett for making repairs in our kitchen while I was "out of commission".

A Mission Resource grant from The Diocese of Bethlehem funded 50% of the new A/V system. The remainder of the A/V system and all other capital projects were funded by the quarterly distribution from the Dr. Conklin DIT fund, and the revised annual distribution from the Bixby endowment. Vestry is grateful for the generosity of Dr. Conklin and the Bixby family.

Discretionary Accounts 2025

The priest has two discretionary accounts available to assist the less fortunate. The Guthrie/Meyer Discretionary Account is limited to parishioners. The Church of the Redeemer Discretionary Fund may be used to assist those in need without regard to affiliation with the parish. Our auditor has previously recommended that the Annual Report contain a summary of the amount of money within the account and a general idea of how the money was spent. Additionally, as part of the Treasurer's Report, the Vestry receives an accounting of discretionary funds spent monthly. Once a month, loose offerings are designated for the Redeemer Discretionary Fund. Interest income from a bequest also funds these accounts.

The loose offerings collected on the first Sunday of the month (funds designated for the Church of the Redeemer Discretionary account) and funds from the Stephens DIT for this discretionary account have been designated for The Bridge. In 2025 we donated \$2484.88 to The Bridge. We have yet to send our 4th quarter donation, however the amount for the 4th quarter will be \$1,095.

From the Church of the Redeemer discretionary fund approximately \$96 was spent on hotel rooms for a person in crisis, \$900 in grocery gift cards, and \$700 for rent. At the beginning of the year, this account had \$3,693.21 and at year end we had \$2,972.97.

From the Guthrie/Meyer Discretionary Funds, which are restricted to members of our parish only, no payments were made. We began the year with \$8,471.31 and ended the year with \$9,871.48.

All funds from the discretionary accounts were spent on those within our community who had no other resources to pay for the requested assistance, in accordance with the Canons of the Episcopal Church and IRS regulations.

All Saints Chapel Columbarium Report 2025

Thank you to Larry Gabb for having name plates engraved for those that are interred in the Columbarium. The All-Saints Chapel Columbarium is located in the undercroft of our church. It is open for meditation whenever the Parish Office is open and by special arrangement at other times. Additional times for visitation may be arranged by calling the Parish Office. Each niche is covered with an attractive brass plate on which a brass name bar is attached. The columbarium was dedicated April 6, 1985. According to the "Functioning Rules" adopted when the columbarium was created, niches are available for purchase by "any Episcopal church member, former member and their relatives."

The cost of a niche is \$300.00, and the corresponding ash container is either \$18.00 or \$21.00 as there is a slight difference in size in the section of the columbarium. The price of the brass plate and engraving are included in the \$300.00 cost. Applications for reservations for niches are available in the church office. All records of purchases and interment are maintained in the church office. Upon purchase of a niche a "Certificate of Ownership" is signed by the rector and a Vestry member and provider of purchase. There are 25 niches available for purchase.

Memorial Gifts 2025

We no longer have a functioning Memorial Committee although we do keep track of monetary gifts (and acknowledge them) through the Parish Office. In 2025, received Memorial Donations in memory of David "Jake Marshall. Our beginning balance was \$4437.30, and we ended the year with \$4719.29.

Outreach Programs **“Souper” Bowl of Caring 2025**

Our “Souper” Bowl pots collected \$168.22 for the Valley Food Pantry in Waverly, NY.

Food Pantries 2025

Our monthly collection is split between the 2 local food pantries. The Valley Food Pantry in Waverly and the Athens United Methodist Church “Feed My Sheep”. Each month a different food item is requested, such as cereal, peanut butter, canned fruit and spaghetti sauce. A total of 286 items were donated in 2025. Thank you to everyone that donates in our little red wagon and the box downstairs.

Community Supper 2025

This was my first year helping direct the activities of the Community Supper, along with Sherry Marshall-Gabauer. I will admit I had big shoes to fill in taking over what Linda Murrelle had done so successfully for many years, but Sherry proved to be an excellent mentor and sidekick (and Sherry is also responsible for securing sponsors for each monthly meal and maintaining communication with those contacts!).

Community Supper, free to any and all, is served from 4:00 to 5:30 PM on the last Thursday of each month, except for November (and often December). We served meals on ten Thursdays in 2025, and held an additional meal on Tuesday, 12/30. In total we served over 1,000 meals, with 1/3 of those being takeout meals. The main kitchen team is comprised of me, Sherry Gabauer, Steve Novak and Nina Seebeck - we work well as a team and we have fun! Thank you to the team and to many others who have assisted in and out of the kitchen throughout the year, including Jerry Evans who does all the "marketing" for the meals! Thank you to all who have donated money to support this ministry, and to our friends at the Feed My Sheep Food Pantry for their support.

Thank you also to the sponsoring groups who pay a sponsorship fee and lend us incredible people to help serve the meal, bring desserts and help clean! This year's sponsor groups were Sayre/Athens Rotary, First Citizen's Community Bank, St. Mary's Guild, Encounter Church, Sayre Christian Church, St. John Lutheran Church and Guthrie Healthcare Cardiac Health professionals. We are blessed to be able to serve in this ministry and we look forward to another year of providing fun, nutritious, delicious free meals.

Musical Sounds Church of the Redeemer 2025

Welcoming parishioners to services at Redeemer are the 2 octaves Carillion. The 14 bells weight is 5,144 pounds. Near the organ is the keyboard on which the bells are played. The Carillion was dedicated in 1974. Also. The tower contains the first town clock in Sayre. As you enter the church next time, take notice of the awesome treasure the tower contains. The beautiful Schantz pipe organ was installed in 1989. On the manual of the organ, 2 octaves of chimes can be played.

David Peckham is the pipe organ and chime guru. He tunes the organ twice a year and whenever maintenance is required. Normally I alternate playing organ and piano for Sunday services. On December 10, Ted Davenport from Apalachin, NY, presented an organ and harp concert. His unique talent is playing without sheet music. His gift of music is unique and was well received. The Children's sermon on December 28 included Rev. Melinda leading the congregation singing "This Little Light of Mine". Everyone knew this song and sang well. The piece I chose for communion that day was "Pass it On". The words to part of the first verse: It only takes a spark to get a fire going, and soon all those around can warm up in its' glowing." Dr. Stanley Conklin

1925

Stanley D. Conklin, MD was a lifelong resident of Bradford County having been born in Rome and practiced medicine at the Robert Packer Hospital for 53 years. In addition to being a pillar of medicine at the hospital, he was active in professional societies as well as in local affairs. In an obituary authored by William Beck and Joseph Cady, it noted that Dr. Conklin was “an unusually devoted husband, he demonstrated particular devotion to his wife, Viven, during her long, final illness. A lifelong member of the Church of the Redeemer, he served his church as both vestryman and senior warden. He was a regular communicant and a loyal supporter of the church.” Dr. Conklin died on June 12, 1989. His funeral was presided over by the Rev. Don R. Greenwood.

Recently the last surviving beneficiary of Dr. Conklin’s estate died. The bequest stipulated that the residual of the estate be distributed to a number of parties, including the Church of the Redeemer. Imagine the Vestry’s surprise to learn in late 2024 some 35 years after Dr. Conklin’s death, that we were to receive an amount that nearly doubled our endowment. Dr. Conklin’s commitment to the Church of the Redeemer outlived him and he has enabled us, in his thoughtfulness, to undertake capital projects to preserve our beautiful historic building and grounds. Vestry has invested the bequest in the Diocesan Investment Trust and so far, has dedicated the interest income to large scale projects. We thank God for the life and legacy of Dr. Conklin.


